- **Site Inspections & Compliance:** Conducting periodic site visits to verify compliance with approved plans and association guidelines.
- **Policy Recommendations:** Recommending updates regarding design criteria, preservation guidelines, and environmental stewardship to the Board of Directors.

III. QUALIFICATIONS FOR CANDIDATES

Eligibility Criteria

- **Must be a property owner, descendant, or POA member in good standing.**
- Commitment to attend monthly committee meetings and participate in site evaluations.
- Fairness, objectivity, and a strong interest in historic preservation and thoughtful community development.
- Background or experience in construction, land surveying, legal/deed review, architecture, or historic preservation is beneficial, but not required.
